# Announcement of Online Short Term Internship Programme August 2024

## (5th August to 16th August, 2024)

The National Human Rights Commission has expressly been mandated to promote Human Rights literacy and awareness vide Section 12 (h) of the Protection of Human Rights Act, 1993. With a view to spread awareness among University students about the need for protection and promotion of Human Rights, the Commission has been regularly conducting *Internship Programmes* since 1998.

- 2. For the Month of August, 2024, a two week "Online Short Term Internship Programme August, 2024 (OSTI- August, 2024)" will commence from 5th August to 16th August, 2024. Applications are invited from eligible students of the entire country. Eligibility and selection criteria will be as follows:
  - a. Students studying in 3rd year and onwards of any integrated 5 year PG Course
  - b. Students studying in 3rd / final year of a graduation course
  - c. Students of any semester/ year of any post-graduate degree course (also applicable to the students in three year LL.B programme).
  - d. Students of any semester/year of any post-graduate diploma course
  - e. Students who are research scholars in any stream.
- 3. Students must have consistently attained a <u>minimum of 60% marks in Class XII</u> and all subsequent years in attended degree or diploma courses, including the presently <u>pursued courses</u>. The calculated percentage has to be mentioned clearly from their CGPA/SGPA along with the formula for percentage obtained. Failure to do either of it, would result in rejection of application form.
- 4. A 250 words write-up on the topic "Statement of Purpose for joining NHRC Online Short Term Internship" will be required to be submitted by the applicants online along with the application form which will also serve as a basis of selection. Students who have research potential in the areas relating to human rights will be preferred (to be indicated in the write-up). The students may also include the details of co-curricular activities, Moot Courts, Internships, research projects for strengthening their application.

- 5. Enclose self attested scanned copies of mark-sheet from 10<sup>th</sup> standard onwards and mark-sheet of each year/semester of graduation & presently pursuing course and letter of recommendation (LOR) by concerned HOD/Dean/Principal which should be of a date subsequent to the date of uploading of this advertisement and for the presently pursued course.
- 6. In absence of following, the applications are liable to be rejected.
  - a. Scanned Self attested mark-sheets of 12th Standard, All Semesters of Graduation Course & marks sheets of all semesters of Pursuing Course.
  - b. Scanned Statement of Purposes (SOPs) and
  - c. Scanned Recommendation letter/email by HOD/Dean/Principal concerned in the annexed Proforma.
- 7. Students who have attended earlier Internship Programmes organized by NHRC will not be eligible to apply.
- 8. This is a <u>full time Internship Programme from 10:00 am to 5:30 pm (Monday to Friday)</u>. Students must ensure about their availability before applying. The student <u>should not be more than 28 years old as on 1st July, 2024.</u>
- 9. <u>Brief Course Structure of Online Short Term Internship (5<sup>th</sup> August to 16<sup>th</sup> August, 2024) would be as stated below- About 45-50 sessions on various human rights issues are proposed to be covered to sensitize the interns. The OSTI- April 2024 will include following inputs:</u>
  - a. Address/Interaction with Hon'ble Chairperson and Members of NHRC and other domain Experts including senior Govt. of India Officials.
  - b. Group Project work on Human Right issues.
  - c. Book Review to be submitted by the students
  - d. Screening of Films on Human Rights concerning child and bonded labour issues, Anti Trafficking, Health including mental health and Education issues
  - e. Virtual Field Visit to Jail, Police Station & NGO/ Shelter Homes. In these virtual visits the interns get to see the working of these institutions and may get their related questions addressed.

#### 10. Awards

- All the student interns successfully completing the internship would receive a stipend of Rs. 2000/- (Rupees Two Thousand only)
- b. Certificate of participation will be awarded to the candidates on the basis of their punctuality, discipline, participation in online sessions; timely submission of Group Project Presentation & Project Reports, and, Book Reviews.

c. It is mandatory for interns to attend all the sessions of the internship. Any application of leave will not be entertained.

## 11. Application for OSTI August, 2024

- a. The last date for submission of the application is 21st July, 2024 (18.00 hours). The 'Application Form' for Short Term Internship Programme-August, 2024 is available at link 'Online Short Term Internship'.
- b. Application to be submitted Online using link Online Short Term Internship available at NHRC's website https://nhrc.nic.in. All the applications should be submitted through this online platform only.
- c. If any discrepancy, such as Marks/CGPA/Percentage is found in the details given in any application, then the applicant will be barred from future programs of NHRC along with rejection of such application.
- 12. Please ensure that the application for OSTI August, 2024 is duly filled. Applications submitted otherwise will not be accepted.
- 13. Incomplete applications / applications without self attested copies of marksheets (10<sup>th</sup> Class, 12<sup>th</sup> Class, All semesters of Graduation Course & pursuing Course), Letter of recommendation & SOPs etc. will be rejected and Applications sent through e-mails/posts will not be entertained. No application will be accepted after the deadline *i.e.* 21<sup>st</sup> August, 2024 (18.00 Hours).
- 13. The Final List of Selected Interns will be displayed on NHRC website.

- 15. The commission reserves the right to discard all/any application, and also to amend or modify the terms and conditions of internship, without assigning any reason.
